I, Danny L. Bagwell, of Greenville County
(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS
WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of
Fifteen Thousand, Nine Hundred Fifty and no/100
Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain
conditions), said note to be repaid with interest as the rate or rates therein specified in installments of
One Hundred Seventeen and 05/100 (\$ 117.05) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the northwestern one-half of Lot No. 11 of a subdivision known as Coleman Heights as is more fully shown on a plat prepared by Terry T. Dill known as Coleman Heights recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 115, and according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of West Drive at the joint front corner of Lots Nos. 11 and 12, and running thence with the joint line of said lots, N. 51-30 E. 183.7 feet to an iron pin on a 20-foot alley; running thence with said 20-foot alley, S. 38-30 E. 104.35 feet to a point; and running thence along a line through Lot No. 11, S. 51-30 W. 183.7 feet to a point on the northeastern side of West Drive; and running thence with the northeastern side of West Drive, N. 38-30 W. 104.35 feet to the point of beginning; being the same property conveyed to me by W R Corporation by deed of even date to be recorded herewith.
