All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the northeast corner of the intersection of Covington Road and Trinity Way, near the City of Greenville, Greenville County, South Carolina, being shown as Lot 66 on Plat of Section II of Northwood Hills, which plat is recorded in the R.M.C. Office for Greenville, S. C. in Plat Book QQ, Page 156, and having, according to said plat, the following metes and bounds, to-wit:
