Advance Builders, Inc., of Greenville

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto SECURITY FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-five Thousand Five Hundred and no/100----- DOLLARS (\$ 25,500.00---), with interest thereon at the rate of Seven & 1/2----- per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is Thirty---- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 8 on plat of Del Norte Estates, Section IV, recorded in Plat Book 4N at page 8 in the RMC Office for Greenville County, and having the following metes and bounds:

Beginning at an iron pin on the western side of Del Norte Boulevard at the joint corner of Lot 7; thence with line of Lot 7, N 84-35 W 119.2 feet to an iron pin; thence N 5-25 E 140 feet to an iron pin on the southern side of Del Norte Road; thence with said Road, S 84-35 E 75 feet to an iron pin on Del Norte Road at corner of Del Norte Boulevard; thence with said corner, S 43-32 E 37.7 feet to an iron pin on the western side of Del Norte Boulevard; thence with the western side of Del Norte Boulevard, S 2-30 E 116.3 feet to the beginning corner.
