SUBORDINATION AGREEMENT

WHEREAS Robert L. Gallamore, d/b/a Ensley Sewing Machine and Fabric Center is presently indebted to the Small Business Administration, evidenced by that certain Promissory Note executed by Robert L. Gallamore, d/b/a Ensley Sewing Machine and Fabric Center and by his wife, Mary L. Gallamore, dated November 23, 1965, in the original principal amount of \$11,800.00 and said Note is secured, among other things, by a certain Real Property Mortgage executed by Robert L. Gallamore and Mary Lee Gallamore in favor of said Bank dated November 23, 1965, recorded in Real Property Book 1015 at Pages 73 et seq., in the Office of Register of Mesne Conveyances of Greenville County, South Carolina; said real property being more particularly described as follows:
