D. R. ROGERS AND MARY ANN G. ROGERS

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto SALUDA VALLEY FEDERAL SAVINGS AND LOAN ASSOCIATION OF Williamston, S. C., (hereinafter referred to as Mortgagee) as evidenced by the

Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by _____

reference, in the sum of SIX THOUSAND TWO HUNDRED AND NO/100 -----DOLLARS (\$ 6,200.00), with interest thereon from date at the rate of eight---- (8%)
per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 90 on a plat of Monticello Estates, dated March 1956 and being recorded in Plat Book EE at page 169 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly edge of North Monticello Road, joint front corner of Lots 89 and 90, and running thence with the line of Lot No. 89, S. 19 W. 180 feet to an iron pin; thence S. 70-20 E. 80 feet to an iron pin; thence N. 19 E. 180 feet to an iron pin on the southerly edge of North Monticello Road; thence along the edge of said Road, N. 70-20 W. 80 feet to the point of beginning.

ALSO: ALL those adjoining lots of land in the State of South Carolina, County of Greenville, situated just below the Town of Piedmont, being known and designated as Lots Nos. 86, 87 and 91, of a subdivision known as Monticello Estates, as shown on a plat thereof, by Woodward Engineering Company, dated March 1956, and recorded in the RMC Office for Greenville County, in Plat Book EE, at page 169, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on Jefferson Drive, joint corners of Lots 87 and 88, and running thence along the line of Lots 87, 88, 90 & 91, N. 19-00 E. 257.7 feet to an iron pin on North Monticello Road; thence running with North Monticello Road, S. 70-20 E. 249.4 feet, more or less, to an iron pin; thence running S. 57-27 E. 59.8 feet to iron pin; thence running S. 0-25 E. 43.2 feet to an iron pin on Jefferson Drive; thence running with Jefferson Drive, S. 73-45 W. 347.13 feet, more or less, to iron pin; thence running, N. 71-00 W. 40.3 feet, more or less, to iron pin at the point of beginning.

There is of record a mortgage executed by the mortgagor to the mortgagee covering the last described property, which mortgage is in the amount of \$13,500.00 and is recorded in Mortgage Book 1036 at page 46. These mortgages shall be of equal rank and a breach or default in either shall constitute a breach of both.
