WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Twelve Thousand, Five Hundred and 00/100 -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Town of Fountain Inn, containing 1/2 A., more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the property now occupied by the Elementary School and running thence S. 31-1/4 W., 3.86 C. to an iron pin, 3X; thence N. 58-3/4 1.10 C. to an iron pin; 3X; thence N. 31-1/4 E., 2.14 C. to an iron pin, 3X; thence N. 58-3/4 W., .44 C. to an iron pin 3X; thence N. 31-1/4 E., 1.72 C. to an iron pin on Main Street; thence along Main Street, S. 58-1/2 E., 1.54 C. to the point of beginning.
