MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

MARJORIE M. SEXTON

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto SECURITY FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of SEVEN THOUSAND and no/100-----DOLLARS (\$ 7,000.00), with interest thereon at the rate of seven and 1/2 per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Eastern side of McAdoo Avenue, being shown and designated as Lot No. 69 on a Plat of GLENN GROVE PARK, dated May 1924, prepared by R. E. Dalton, Engineer, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book F, Page 233, and having according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Eastern side of McAdoo Avenue at the joint front corner of Lot 68 and 69, thence with the line of said lots, S. 74-12 E., 150 feet to an iron pin; thence with the line of Lot No. 46 S. 15-48 W., 50 feet to an iron pin at the joint rear corner of Lots 69 and 70; thence with the common line of said lots, N. 74-12 W., 150 feet to an iron pin on the Eastern side of McAdoo Avenue, which point is 116.1 feet North of the intersection of McAdoo Avenue and Monticello Avenue; thence along the Eastern side of McAdoo Avenue, N. 15-48 E., 50 feet to an iron pin, the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
