WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eight Thousand and No/100----- DOLLARS

(\$ 8,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is ten years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being shown and designated as Lots Nos. 1 and 2 on a Plat of the Property of A. F. Ballentine, dated August, 1924, made by R. E. Dalton, Engineer, and being recorded in the RMC Office for Greenville County, S. C., in Plat Book F, page 250, less, however, the rear 30 feet of each lot heretofore conveyed away by deed recorded in Deed Book 421, page 542, and having the following metes and bounds, to wit:

BEGINNING at an iron pin at the Northeastern intersection of Haynie Street with an unnamed street (now Haynie Court); thence along the Northern side of Haynie Street, N. 81-02 E., 98 feet to an iron pin; thence N. 9-45 W., 70 feet to a point; thence on a line through Lots Nos. 1 and 2, S. 81-02 W., 98 feet to a point on the Eastern side of an unnamed street (now Haynie Court); thence with the Eastern side of said Court, S. 9-45 E., 70 feet to an iron pin, the beginning corner.
