WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of EIGHTEEN THOUSAND AND NO/100THS - - - - -

DOLLARS (\$ 18,000.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southeastern side of Sir Abbott Street in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 107 as shown on a plat of Sherwood Forest, prepared by Dalton & Neves, Engineers, dated November, 1952, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book GG at pages 2 and 3, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Sir Abbott Street at the joint front corner of Lots Nos. 106 and 107 and running thence with the line of Lot No. 106 S. 27-14 E. 155 feet to an iron pin; thence S. 62-46 W. 75 feet to an iron pin in the joint rear corner of Lots Nos. 107 and 108; thence with the line of Lot No. 108 N. 27-14 W. 155 feet to an iron pin on the Southeastern side of Sir Abbott Street; thence with the Southeastern side of Sir Abbott Street N. 62-46 E. 75 feet to the point of beginning.
