All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Mark Drive at the intersection of Riley Road and Mark Drive, and being shown and designated as Lot No. Four (4) on plat of the property of Ernestine Massey by Webb Surveying & Mapping Company dated August 1, 1969 and recorded in the R. M. C. Office for Greenville County in Plat Book 4 F, page 7. This being a portion of the property conveyed to Ernestine M. Massey by W. R. Smith by deed recorded in the R. M. C. Office for said County in Deed Book 355, page 473, and being the same property conveyed to mortgagor herein by Ernestine M.
