bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its
successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon,
situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs
Township, and being known and designated as lot no. Six (6) of Lake
View Heights property of Mrs. Bessie and I. M. Wood Estate as shown on
plat prepared by H. S. Brockman, Reg. Surveyor, dated Nov. 2, 1959 and
which plat has been recorded in the R. M. C. Office for said County in
