NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**State of South Carolina:

ALL that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and having, according to a plat of Property of Julia M. Goldsmith, by Carolina Surveying Co., dated October 13, 1971, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southwestern edge of White Horse Road, which iron pin is located 50 feet in a northwesterly direction from an iron pin on the southwesterly edge of White Horse Road at the "original property line" and running thence S. 44-30 W. 160 feet to an iron pin; thence N. 54-05 W. 100.0 feet to an iron pin; thence N. 44-30 E. 160 feet to an iron pin on the southwestern edge of White Horse Road; thence with the southwestern edge of said road, S. 54-05 E. 100 feet to an iron pin, being the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided.
