WHEREAS, the Mortgagor is well and truly indebted unto SALUDA VALLEY FEDERAL SAVINGS AND LOAN ASSOCIATION OF Williamston, S. C., (hereinafter referred to as Mortgagee) as evidenced by the

Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Nineteen thousand and No/100-----

DOLLARS (\$19,000.00), with interest thereon from date at the rate of Eight (8%) per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Grove Township**, constituting a portion of the property shown on a plat entitled "Property of R. P. McAbee" recorded in Plat Book GGG, at page 289 and being described as follows, in accordance with a plat prepared by R. D. Garrison, Surveyor, dated September 7, 1971:

BEGINNING at an iron pin on the northerly side of a new cut road known as Golden Grove Circle, said iron pin being located N. 86-22 W. 357.3 feet, more or less, from the intersection of said Circle and S. C. Highway #20, and running thence along the northerly edge of said Golden Grove Circle, N. 86-22 W. 160 feet to an iron pin; thence N. 10-48 E. 190.4 feet to an iron pin on the line of property of McAbee; thence along the line of McAbee, S. 77-19 E. 160 feet to an iron pin; thence S. 11-13 W. 165.2 feet to the point of beginning.
