MORTGAGE

STATE OF SOUTH CAROLINA
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS-MAY CONCERN:

Fred B. Sanford and
Dorothy M. Sanford

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-three Thousand Five Hundred and no/100-----DOLLARS

(\$ 43,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the northeast side of Seabrook Court, being a portion of the property as shown on plat entitled "Property of Herbert Wright" made by Webb Surveying and Mapping Co. August 16, 1968, recorded in the R.M.C. Office for Greenville County in Plat Book ZZZ at Page 11, and being more particularly described in accordance with revised plat made by Webb Surveying and Mapping Company November 1971 as follows:

Beginning at an iron pin on the northeast side of Seabrook Court, corner of property of Bazemore and running thence with the northeast side of Seabrook Court, S. 32-23 E. 104.6 feet to a point; thence continuing S. 3-37 W. 20.8 feet to a point; thence with a new line through said lot N. 59-43 E. 154.7 feet to an iron pin; thence S. 79-36 E. 32.6 feet to an iron pin; thence N. 81-42 E. 28.9 feet to an iron pin; thence N. 33-00 E. 96.8 feet to an iron pin in the rear line of Gilbert property; thence N. 50-51 W. 148 feet to an iron pin in the rear line of Bazemore property; thence with the line of said property S. 52-45 W. 235.5 feet to the point of beginning.

This is the same property conveyed to the mortgagors by deed of Jo Ann C. Wright to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
