All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being on the southern side of Best Drive (formerly Springfield Street) and being known and designated as Lot No. 2 on a plat of PROPERTY OF JAMES H. LINDSEY III and recorded in the RMC Office for Greenville County in Plat Book III at Page 59, reference to said plat being craved for a more complete and detailed description thereof; said plat being made a part hereof and incorporated herein by reference.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
