NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that piece, parcel or lot of land in Oaklawn Township, Greenville County, State of South Carolina, on the East side of Greenville Road, originally containing three (3) acres, more or less, bounded on the South and East by Lot No. 4 of the Emma J. Beam land, on the North by Lot No. 1 and on the West by Lot No. 3, all in the Subdivision of the Emma J. Beam land, and having the following metes and bounds, to-wit:

BEGINNING in Greenville Road, thence S. 5h2 E. 6.33 to road X3; thence N. 352 E. 4.7h to rock X3; thence N. 5h2 W. 6.33 to said road; thence along the road S. 352 W. 4.7h to the beginning corner, and more fully represented by a plat made by Wm. F. Lee, Surveyor, dated January 30. 1911.
