C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, in or near the Town Limits of Greer on the North side of dual lane Highway No. 29, as shown on a survey entitled Map of Boy Scouts Property, dated July 3, 1951, by H. S. Brockman, Surveyor, and having, according to said plat, the following metes and bounds, to wit:

Beginning at a point on the right-of-way line on U. S. Highway no. 29, adjoining the property now or formerly of the City of Greer and running thence N. 11-27 E. 55 feet, more or less, to an iron pin; thence continuing N. 11-27 E. 170.5 feet to an iron pin; thence N. 77-27 W. 358.5 feet to an iron pin; thence N. 24-42 E. 248 feet to an iron pin; thence S. 89-40 E. 439 feet to the center line of a branch; thence along and with center of branch as a line, S. 36-35 W. 97.7 feet, S. 15-47 W. 85.6 feet; thence S. 5-10 W. 97.5 feet; thence leaving branch S. 25 E. 276.8 feet to an iron pin on the right-of-way of Highway No. 29, N. 85.20 W. 80 feet to an iron pin; thence S. 4-15 W. 25 feet to an iron pin; thence in a westerly direction approximately 221 feet to the beginning corner.
