NOW, KNOW ALL MEN, That the Mortgager, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgager may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgager in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereat is hereby acknowledged, has gramed, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, shown as Lot no. 4 on plat prepared by C. O. Riddle, RLS, dated April 22, 1954, entitled "Estate of John Jackson", and having, according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin in the center of a 15 foot road at the joint corner of lots 3 and 4 and running thence with the center of said road, N. 14-30 W. 151 feet to a pin at the joint corner of lots 4 and 5; thence with the line of lot 5, N. 75-30 E. 287.1 feet to an iron pin; thence S. 14-30 E. 151 feet to an iron pin at the rear corner of lot 3; thence with the line of lot 3, S. 75-30 W. 287.1 feet to the beginning corner.

This property is a portion of the land conveyed to the Grantor by Marcell Jackson by deed dated July 2, 1964, recorded July 7, 1964, in Deed Book 752, page 422, R.M.C.
