-seven- per centum ( -7-%) per annum until paid, said principal and interest being payable

whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does  
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described  
property situated in the county of Greenville  
State of South Carolina; being shown as Lot 86 on plat of Brook Glenn  
Gardens recorded in Plat Book JJJ at page 85 in the RMC office  
for Greenville County, and fronting on Ravensworth Road.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances  
to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that  
the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all
