To All Whom These Presents May Concern: We, Calvin P. Millinax and

Hazel P. Mullinax

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

THREE THOUSAND & NO/100 - - - - -  
DOLLARS (\$ 3,000.00 - - ), with interest thereon from date at the rate of eight (8%)  
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, as shwon on Plat of Survey prepared by Terry T. Dill, dated September 7, 1971, as having the following metes and bounds, to-wit:

BEGINNING at an iron pin at Langley Road and running N. 18-00 W. 529.5 feet to corner iron pin; thence along line of Poole property S. 72-00 E. 226.5 feet to corner iron pin at joint corner of Poole, Davis & other property of Styles; thence S. 18-00 E. 400 feet to iron pin on Langley Road; thence along line of said Langley Road S. 73-27 W. 185 feet to iron pin and point of beginning, containing 1.95 acres, more or less.

This being a part of that same property conveyed to J. D. Styles by deed of James Burns and Mildred P. Burns.
