BEGINNING at an iron pin on the east side of Elkwood Street at the joint corner of Lots 22 and 23 and runs thence along the line of Lot 22 S. 78-49 E. 150.5 feet to an iron pin; thence N. 14-18 E. 139.8 feet to an iron pin; thence along the line of Lot 24 S. 87-57 W. 181.4 feet to an iron pin on the east side of Elkwood Street; thence along Elkwood Street S. 2-03 E. 49.1 feet to an iron pin; thence with the curve of Elkwood Street (the chord being S. 3-02 W. 50.9 feet) to the beginning corner.
