TO ALL WHOM THESE PRESENTS MAY CONCERN

WHEREAS, we, Gordon D. Seay and Diane H. Seay, are

(hereinafter referred to as Mortgagor) is well and truly indebted unto Southern Bank and Trust Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty Thousand and No/100

Dollars (\$ 40,000.00) due and payable

in monthly instalments of Eight Hundred Twelve and No/100 (\$812.00) Dollars, beginning on the first day of March, 1972 and continuing in monthly instalments of Eight Hundred Twelve and No/100 (\$812.00) Dollars until paid in full.

with interest thereon from date at the rate of 8% per centum per annum, to be paid: on the balance

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northwestern side of Rockwood Drive, being shown as Lot 68 on plat of Rockwood Park recorded in the R. M. C. Office for Greenville County in Plat Book S at Pages 168 and 169; said lot fronts 200.4 feet along the northwestern side of Rockwood Drive, running back along the east side of Frontus Street 234.5 feet, and running back to a depth of 164.5 feet on the northeastern side."

This is a second mortgage, being second and junior in lien to that certain mortgage given to Carolina National Mortgage Investment Co., Inc. on October 1, 1965 in the original amount of \$ 17,700.00 and recorded in the R. M. C. Office for Greenville County in Mortgage Book 1009, at Page 367.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
