## MORTGAGE

STATE OF SOUTH CAROLINA  
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

M. G. Proffitt, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty-One Thousand Five Hundred and No/100-----

DOLLARS (\$ 41,500.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northerly side of Runnymede Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 88 on a plat of Foxcroft, Section I, as recorded in the Office of the RMC for Greenville County in Plat Book 4F, Pages 2, 3 and 4, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northerly side of Runnymede Road, said pin being the joint front corner of Lots 88 and 89, running thence with the common line of said lots, N. 45-29 W. 202.2 feet to an iron pin, joint corner of Lots 88 and 89; thence N. 19-50 E. 80 feet to an iron pin in line of Lot 82; thence N. 86-44 E. 120 feet to an iron pin, the joint rear corner of Lots 87 and 88; thence with the common line of said lots, S. 25-26 E. 189.5 feet to an iron pin on the Northerly side of Runnymede Road; thence with the Northerly side of Runnymede Road, S. 62-49 W. 50 feet to an iron pin; thence continuing with said lots, S. 52-49 W. 50 feet to an iron pin, the point of beginning.
