NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and re-leased, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon,

situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Augusta Road, just outside the City of Greenville, South Carolina, having the following metes and bounds:

Beginning at an iron pin on the eastern side of Augusta Road at joint front corner of property herein and Lydia Street (formerly an 18-foot easement) and running thence with the northern side of Lydia Street, N 73-33 E 114.7 feet to an iron pin; thence N 2-48 W 100.4 feet to an iron pin; thence S 87-17 W 105.5 feet to an iron pin on the eastern side of Augusta Road; thence S 0-01 E 138.10 feet to the beginning corner, LESS, HOWEVER, that portion of said property as may have been taken by condemnation proceedings to widen Lydia Street.
