ALL that piece, parcel or lot of land together with buildings and improvements now or hereafter constructed thereon, situate, lying and being on the Eastern side of Williamsburg Drive, in Gantt Township, Greenville County, South Carolina, being shown and designated as Lot No. 4 on a Plat of BELLE MEADE, Sections 1 and 2, Property of Derby Heights, Inc., made by Piedmont Engineering Service, dated June, 1954, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book EE, pages 116 and 117, reference to which is hereby craved for the metes and bounds thereof.
