NOW, KNOW ALL, MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

ALL that certain piecs, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of _____ GREENVILLE______ to wit:

IN GANTT TOWNSHIP, BEING KNOWN AND DESIGNATED AS A PORTION OF TRACT NO. 6 OF THE PROPERTY OF THE ESTATE OF ELLA EASLEY AS SHOWN ON SUBDIVISION AND PLAT OF SAME MADE BY R. E. DALTON, ENGINEER, FEBRUARY 1923 FRONTING 85 FEET ON PLANTATION ROAD LEADING THROUGH TRACT NO. 6 AND PROPERTY OF ROCK HILL BAPTIST CHURCH AND RUNNING BACK BETWEEN PARALLEL LINES AD DISTANCE OF 115 FEET, THE NORTH LINE OF SAID PROPERTY RUNNING ALONG THE LINE OF PROPERTY OF ROCK HILL BAPTIST CHURCH, BOUNDED ON THE NORTH BY PROPERTY OF SAID ROCK HILL BAPTIST CHURCH, ON THE EAST AND SOUTH BY REMAINING PORTION OF LOT NO. 6 OWNED BY OTIS DAVIS AND ON THE WEST BY SAID PLANTATION ROAD

THIS BEING THE SAME PROPERTY CONVEYED TO THE HORTAGOR BY DEED DATED MAY 15, 1950 AND RECORDED IN THE RMC OFFICE FOR GREENVILLE COUNTY IN DEED BOOK 409, AT PAGE 239.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covehants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as herein specifically stated otherwise as follows:

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortagagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All aums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.

(2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgagee debt, whether due or not.
