onth hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner id, to be due and payable 29 years after date; and
WHEREAS, said note further provides that if at any time any portion of the principal or interest the thereunder shall be need

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville on the Northeastern side of Pryor Road, known and designated as Lot No. 78 of a subdivision known as Avondale Forest, Section II, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book BBB at Page 34, and having according to said plat, the following metes and bounds to-wit:

BEGINNING on the Northeastern side of Pryor Road at the joint front corner of Lots Nos. 77 and 78, thence running along Pryor Road N. 49-47 E., 90 feet to an iron pin joint front corner of Lots Nos. 78 and 79; thence running along the common boundary of Lots Nos. 78 and 79 S. 43-52 E., 180.9 feet to an iron pin; thence S. 22-34 E., 70.4 feet to an iron pin; thence S. 89-02 W., 30.0 feet to an iron pin; thence along the joint line of lots Nos. 77 and 78 N. 45-03 W., 193.7 feet to an iron pin; point of beginning.
