MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: MYRTLE MORRISON MCGRIFF

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto BANK OF TRAVELERS REST

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Five Thousand and No/100 ----- DOLLARS (\$5,000.00)

with interest thereon from date at the rate of eight per centum per annum, said principal and interest to be repaid:

one year from date with interest at eight (8) percent annually in advance.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, situate on the outskirts of the village of Travelers Rest, being known and designated as Lot no. 26, on a plat of "Love Estates", which said plat is recorded in the RMC Office for Greenville County in Plat Book I at Pages 111 and 112, and is described by courses and distances as follows, to-wit:

BEGINNING at a corner on the south side of the school house road and running thence along the joint line of Lots nos. 26 and 27, S 26 E 201 ft. to corner; thence S 81 E 30.8 ft. to corner; thence N 46-50 E 77.8 ft. to corner on Lot no. 25; thence along the joint line of 25 and 26, N 26 W 196.5 feet corner of the road; thence along the south side of said road S 64 W 100 ft. to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
