Twelfth: BOOKS, RECORDS AND ACCOUNTS. The Borrower will keep and maintain or will cause to be kept and maintained proper and accurate books, records and accounts reflecting all items of income and expense in connection with the operation of the premises or in connection with any services, equipment or furnishings provided in connection with the operation of the premises, whether such income or expenses be realized by the Borrower or by any other person or entity whatsoever excepting sublessors unrelated to and unaffiliated with the Borrower and who leased from the Borrower portions of the same. Lender shall have the right from time to time at all times during normal business hours to examine such books, records and accounts at the office of the Borrower or other person or entity maintaining such books, records and accounts and to make copies or extracts thereof as Lender shall desire.
