MORTGAGE OF REAL ESTATE.

Whereas, George A. Roberson & Charlotte Ann Roberson

of the County of Greenville, in the State aforesaid, hereinafter called the Mortgagor, is

indebted to Stephenson Finance Company, Inc.

a corporation organized and existing under the laws of the State of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference

in the principal sum of ***One thousand two hundred ninety six and no/100 Dollars (\$ 1,296.00), and,

Whereas, the Mortgagee, at its option, may hereafter make additional advances to the Mortgagor, or his successor in title, at any time before the cancellation of this mortgage, which additional advance(s) shall be evidenced by the Note(s) or Additional Advance Agreement(s) of the Mortgagor, shall bear such maturity date and other provisions as may be mutually agreeable, which additional advances, plus interest thereon, attorneys' fees and Court costs shall stand secured by this mortgage, the same as the original indebtedness, provided, however, that the total amount of existing indebtedness and future advances outstanding at any one time may not exceed the maximum principal amount of

Ten thousand three hundred twenty five and no/100 Dollars (\$ 10,325.00), plus interest thereon, attorneys' fees and Court costs.

Now, Know All Men, the Mortgagor in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of One Dollar (\$1.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns the following-described property:

Beginning at an iron pin on Farr's Bridge Road (South Carolina Hwy., 183) which iron pin is the joint corner of property of the grantors and Berea Baptist Church and running thence S. 24 - 20 W. 506.8 feet to an iron pin; thence S. 0-21 E. 378.2 feet to an iron pin; thence S. 46-02 E. 97.2 feet to an iron pin; thence S. 6-53 W. 273.8 feet to an iron pin; thence S. 8-51 E. 411.3 feet to an iron pin; thence N. 76-58 W. 373.2 feet to an iron pin; thence N. 80-30 W. 300.3 feet to an iron pin; thence N. 31-55W 453.0 feet to an iron pin; thence S. 29-09 W. 936.4 feet to a point in the center of a County road; thence S. 75-04W. 68.7 feet to a point; thence S. 60-21W. 78.4 feet to a point; thence N. 19-01 W. 639.0 feet to a point in a creek; thence along said creek N. 67-35E. 78.0 feet to a point; thence continuing along said creek N. 83-18E. 139.2 feet to a point; thence continuing along said creek S. 57-43 E. 128.0 feet to a point; thence N. 36-09 E. 607.7 feet to an iron pin; thence N. 35-57 E. 1302.9 feet to an iron pin on Farr's Bridge Road; thence along Farr's Bridge Road S. 66-22 E. 207.9 feet; thence continuing along Farr's Bridge Road S. 61-50 E. 190.3 feet to an iron pin the point of beginning.
