NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about 5 miles North of Greer on the Southeast side of a County Road containing 2.2 acres, more or less, as shown on a survey for Stephen Southern dated August 10, 1971, by W. N. Willis, Engineer, to be recorded herewith and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of a County Road and running thence N. 48-15 W. 270 feet to an iron pin; thence N. 39 B. 300 feet to an old iron pin; thence S. 48-15 E. 350 feet to an old iron pin; thence S. 12-W. 85 feet to an iron pin in the center of a Road; thence with feet to an iron pin; thence S. 36-10 W. 162 feet to the point of beginning.
