

**MORTGAGE ON REAL ESTATE**

These presents may concern:

Lucille T. Hall

The Peoples National Bank, Simpsonville, South Carolina,

as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference.

Nine thousand and no/100 ----- Dollars (\$ 9,000.00 ) due and payable

In monthly installments of \$109.20 per month, to be applied first to interest and then to principal, for a period of ten (10) years,

with interest thereon from date at the rate of eight (8%) per centum per annum to be paid: monthly.

WHEREAS the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying and being about one mile East from Brushy Creek Baptist Church, and being a part of the southern portion of the same tract of land conveyed to Lucille T. Hall, and having the following metes and bounds to wit:

BEGINNING at an iron pin on B.P. & W. T. Hall line and runs thence a new line N. 2-30 E., 210 feet to iron pin; thence S. 89-00 W., 105-feet to another iron pin on S.M. McCoy Estate line; thence with said line S. 2-30 W., 210 feet to old iron pin; thence with the B.P. and W.T. Hall line N. 89-00 E., 105 feet to the point of beginning and being bounded on the North and East by Hall and on the West by lands of S.M. McCoy Estate and on the South by lands of B. P. and W.T. Hall.

ALSO a right-of-way across driveway as shown on plat entitled property of Lucille T. Hall, prepared by H. S. Brockman, dated November 25, 1966, from the property described above in a southerly direction to a public road.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
