NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgager to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted; bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Butler Drive and being known and designated as Lot 5 on Plat of Property of T. D. Burdette, recorded in the R. M. C. Office for Greenville County, in Plat Book 4-F, at Page 37, andhaving according to said Plat, the following metes and bounds, to-wit:

Beginning at a point in the center of Butler Drive at the joint front corner of Lots 4 and 5, and running thence along the center of said Drive N. 84-18 E. 209 feet to a point; thence S. 6-27 W. 213.2 feet to an iron pin; thence S. 84-18 W. 209 feet to an iron pin; thence N. 6-27 E. 213.2 feet to the point of beginning.
