TO ALL WHOM THESE PRESENTS MAY CONCERN:

James E. Burger

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-One Thousand, Six Hundred and 00/100 -----

DOLLARS (\$ 21,600.00), with interest thereon from date at the rate of Seven & Three-Quarter per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Panorama Court, being shown and designated as Lot 21 on a Plat of Plantation Estates, made by Campbell and Clarkson, Surveyors, dated December 16, 1971, and recorded in the R.M.C. Office for Greenville County in Plat Book 4-N, Page 48, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern edge of Panorama Court, at the joint front corner of lots 21 and 22 and running thence with the joint line of lots 21 and 22, S. 11-10 W., 250 ft. to an iron pin; thence S. 78-50 E., 100 ft. to an iron pin at the joint rear corner of lots 20 and 21; thence with the joint line of lots 20 and 21, N. 11-10 E., 250 ft. to an iron pin on the Southern edge of Panorama Court; thence with the Southern edge of Panorama Court, N. 78-50 E., 100 ft. to an iron pin being the point of beginning.

This is the same property as conveyed to the mortgagor by deed of Dempsey Real Estate Company, Inc., to be recorded of even date herewith.
