WHEREAS, Fountain Inn Federal Savings and Loan Association as mortgagee has agreed to consent to the transfer of said property and allow the assumption of the mortgage balance by the undersigned on condition that the undersigned agree that the interest rate as set forth in said mortgage and in the note which it secures be increased beginning June 1, 1972 to 75% per annum;
