NOW, KNOW ALL MEN that Mortgagor (all if more than one), to secure payment of a Promissory Note of even date from Mortgagor to Universal C.I.T. Credit Company (hereafter "Mortgagee") in the above Total of Payments and all future advances from Mortgagee to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all improvements thereon situated in South Carolina, County of Greenville

All that lot of land with improvements, in Bates Township, Greenville County, State of South Carolina, lying on the west side of a County Road in Little Texas Community, and bounded by lands of James Keeler, M. I. J. Edwards and other lands of Grantor, containing 0.41 acres, more or less, and having the following metes and bounds:

BEGINNING at an angle iron formerly a persimmon, corner for lands of Grantor, Keeler, and Edwards, and running thence S. 43 W. 200 feet to iron pin; thence N. 42 W. 90 feet to iron pin; thence N. 43 E. 200 feet over iron pin on west bank of road to point in Edwards line in road; thence S. 42 E. 90 feet to beginning corner.

Mortgagor also agrees to maintain insurance in such form and amount as may be satisfactory to the Mortgagee in Mortgagee's favor, and in default thereof Mortgagee may, but is not obligated to, effect said insurance in its own name.

Any amount which Mortgagee may expend to discharge any tax, lien, assessment, obligation, covenant, insurance premium, prior mortgage or any charge whatsoever in connection with the above described real estate shall be an additional lien secured by this mortgage with interest at the highest lawful rate if not prohibited by law, and may be enforced and collected in the same manner as the debt hereby secured.

All obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand, upon any default.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
