## MORTGAGE

STATE OF SOUTH CAROLINA  
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Nathaniel Morgan (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand Five Hundred -----

DOLLARS (\$2,500.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, May 1, 1978.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being near the City of Greenville, in Gantt Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 12 as shown on a plat prepared by C. C. Jones, C. E., dated July 27, 1963, entitled "Section 3, Fairfield Acres", recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book EEE at page 35, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Ledford Drive at the joint front corner of Lots Nos. 12 and 13, and running thence with the line of Lot No. 13 S. 19-27 W. 153 feet to an iron pin; thence S. 87-35 E. 118.5 feet to an iron pin at the joint rear corner of Lots Nos. 11 and 12; thence with the line of Lot No. 11 N. 12-57 E. 119.5 feet to an iron pin on the Southern side of Ledford Drive; thence with the Southern side of Ledford Drive N. 70-35 W. 100 feet to the point of beginning.

This is the identical property conveyed to the mortgagor herein and Carrie Lou Morgan by deed of Minnie B. Gregory dated September 23, 1963, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 732 at page 236. The said Carrie Lou Morgan conveyed her interest in the premises to the mortgagor herein by deed dated May 10, 1972, and to be recorded herewith in the R. M. C. Office for Greenville County, South Carolina.
