WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Twenty Seven Thousand Five Hundred and no/100ths--**

DOLLARS (\$ 27,300.00 ), with interest thereon from date at the rate of **seven & one-half** per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, known as **Lot 52 on plat of Buxton recorded in the RMC Office for Greenville County in Plat Book 4-N at page 2** and having, according to said plat, the following metes and bounds, to-wit:

**BEGINNING** on the southwestern side of Winsford Drive at the corner of Lot 51 and running thence S 49-18 E 160.4 feet to an iron pin; thence along the right-of-way line of Duke Power Company, N 36-30 W 133 feet to an iron pin; thence N 53-57 W 160 feet to an iron pin on the southwestern side of Winsford Drive; thence with said Drive S 36-30 E 120 feet to the point of beginning, and being the same property conveyed to me by Buxton Development Corporation by deed to be recorded of even date herewith.
