To All Whom These Presents May Concern:

I, Jimmy Brooks

SEND GREETING:

WHEREAS, I the said Jimmy Brooks

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of One thousand two hundred and no/100-----(\$1,200.00) Dollars, with interest from the date hereof at the rate of eight per cent (8%) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

fifty four and 28/100-----(\$ 54.28) Dollars due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That I the said Jimmy Brooks

, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor, in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville; Chick Springs Township, in the Town of Taylors, known and designated as lot numbers THREE (3) and TWO (2) on plat of Riverside Park, recorded in the R. M. C. Office for Greenville County in plat book QQ page 26-27 and according to said plat having the following metes and bounds, to wit:

BEGINNING at an iron pin on the south side of Riverside Drive at the joint corners of Lots Nos. 3 and 8 and running thence on South side of Riverside Drive S. 68-07 E., 136 feet to intersection of Riverside drive and a street; thence along the western side of said street, S. 27-30 W., 120 feet to joint corner of lots Nos 1 and 2; thence along the line of Lot No. 2, N. 65-40 W., 96 feet; thence along the line of Lot No. 2 and 3, N. 6-40 E., 122 feet to the beginning corner.

This is the same conveyed to Winzer Clay by Taylors Lumber Company by deed recorded in deed book 783 page 284, Greenville County R. M. C. Office.

This is the same property conveyed to me by Winzer Clay by Deed dated May 31, 1972 to be recorded in the R. M. C. Office for Greenville County.

ALSO: All that piece, parcel or lot of land in State and County aforesaid, in Chick Springs Township, near Taylors, S. C. and being shown and designated as lot number ONE (1) of Riverside Park, as shown on plat prepared by W. N. Willis, surveyor, dated May 8, 1953 and having the following courses and distances, to wit:

BEGINNING at an iron pin on the northwestern corner of the intersection of a County Road and a 40 feet street and running thence with the east side of said County Road, N. 38-31 W., 78 feet to an iron pin at the joint front corner of lots 1 and 9, as shown on said plat; thence with the joint property line of said two lots, N. 6-40 E., 66 feet to an iron pin at the joint rear line or corner of lots 1, 2, 8 and 9 as shown on said plat; thence with the joint line of said lots 1 and 2, S. 65-40 E., 96 feet to an iron pin on the west side of said 40 feet street; thence with the west side of said street S. 27-30 W., 99.4 feet to the beginning corner.
