First Mortgage on Real Estate

**MORTGAGE**

STATE OF SOUTH CAROLINA  
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

PHILIP K. TRAMMELL

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWELVE THOUSAND AND NO/100----- DOLLARS

( \$ 12,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being an Eastern portion of Lot No. 13 of Highview Acres (see Plat Book 0, Page 123, R.M.C. Office for Greenville County, South Carolina), and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the Southern edge of Long Forest Drive, which said point is 230.8 feet East of the intersection of Courtland Drive and Long Forest Drive and running with said Long Forest Drive, S. 66-30 E. 93.5 feet to an iron pin, joint corner of property of the Grantor and Greenville Rental Co; thence running with joint line with Greenville Rental Co., S. 19-17 W. 149.1 feet to an iron pin; thence, N. 84-30 W. 84.5 feet to an iron pin; thence, N. 15-29 E. 176 feet to a point on the edge of Long Forest Drive, the point of beginning.

This being a portion of the property conveyed to the Mortgagor herein by deed recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 930, at Page 225.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
