NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to Universal C.I.T. Credit Company (hereafter "Mortgagee") in the above Total of Payments and all future advances from Mortgagee to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all improvements thereon situated in South Carolina, County of Greenville

All that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, containing 2.04 acres, according to a plat of Midway Acres, property of S.C. Beattie Estate by Terry T. Dill (2nd Block) and having the following metes and bounds, according to said plat: Beginning at an iron pin at the intersection of Midway Road and a 50 foot street and running thence along said 50 foot street, South 40-30 East 417.8 feet to an iron pin; running thence North 47-36 East 217 feet to an iron pin; running thence North 42-24 West 417.4 feet to an iron pin on Midway Road; running thence along said Road South 47-36 west 208.7 feet to an iron pin, the beginning corner.

Any amount which Mortgagee may expend to discharge any tax, lien, assessment, obligation, covenant, insurance premium, prior mortgage or any charge whatsoever in connection with the above described real estate shall be an additional lien secured by this mortgage with interest at the highest lawful rate if not prohibited by law, and may be enforced and collected in the same manner as the debt hereby secured.

All obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand, upon any default.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
