All that certain piece, parcel lot of land situate lying and being in the county of Greenville state of S. C. being known and designated as Lot no. 30 on the western side of Farmington road, and having according to a plat of Chestnut Hills filed in the RMC office for Greenville county in Plat Book GG page 35 the following metes and bounds to wit:
