"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that lot of land in Greenville County, State of South Carolina, on Imperial Drive, being shown as Lot No. 377, on a Plat of HERITAGE HILLS, Section III, recorded in Plat Book 4F at Page 26, in the R.M.C. Office for Greenville County, S. C., and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 377 and 378 and running thence S. 84-00 E. 123 feet to an iron pin at the joint front corner of Lots 377 and 376; thence S. 6-0 W. 160.7 feet; thence S. 89-07 W. 123.7 feet to an iron pin; thence N. 6-00 E. 175.5 feet to an iron pin, the point of beginning.
