KNOW ALL MEN BY THESE PRESENTS, for value received,

following metes and bounds:

BEGINNING at an iron pin on the west side of South  
Carolina Highway 291 - South Pleasantburg Drive,  
joint corner of property of Star Enterprises, Inc.  
and property of Stafac, Inc., which point is N.  
6-50 W. 200 feet from the northwest corner of the  
intersection of Cleveland Street and South Carolina  
Highway 291 - South Pleasantburg Drive, and running  
thence along the western side of South Carolina  
Highway 291 - South Pleasantburg Drive, N. 6-50  
W. 285 feet to an iron pin, corner of property  
now or formerly of Eight Associates, Inc.; thence  
turning and running along the line of property  
now or formerly of Eight Associates, Inc. S. 83-10  
W., 223 feet to a point in the joint line of  
Parcels "F" and "D" shown on said plat; thence  
turning and running S. 6-50 E. 299.2 feet to a  
point in line of property of Star Enterprises, Inc.;  
thence turning and running N. 83-10 E. 74.8 feet  
(a portion of which distance runs along the line of  
property of Charles B. Barnett) to an iron pin, joint  
corner of property of Charles B. Barnett and Stafac,  
Inc.; thence along the line of property of Stafac,  
Inc., N. 78-06 E. 150 feet to a point on the west  
side of South Carolina Highway 291 - South Pleasant-  
burg Drive, the beginning corner.

Enterprises, Inc. by C. Heyward Morgan, et al, by  
deed dated August 1, 1960, and recorded in the Office
