## MORTGAGE

STATE OF SOUTH CAROLINA  
COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: Jack T. Norman and Mary W. Norman

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seventeen Thousand and no/100-----  
DOLLARS (\$ 17,000.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the west side of Cardinal Court, Greenville County, State of South Carolina and being shown as lot no. 31 on a plat of Fowler Fields recorded in Plat Book 4 F at Pages 56 and 57 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Cardinal Court at the joint front corner of lots 31 and 32 and running thence with the common line of said lots, S. 83-38 W. 197.8 feet to an iron pin at the joint rear corner of lots 29, 31 and 32; thence N. 65-39 W. 12.9 feet to an iron pin in the common line of lots 29 and 30; thence N. 20-34 E. 196 feet to an iron pin on Quail Trail; thence S. 69-26 E. 115.4 feet to an iron pin; thence S. 37-54 E. 33.7 feet to an iron pin on the western side of Cardinal Court; thence with Cardinal Court S. 6-22 E. 100.8 feet to the point of beginning.
