All that certain piece, parcel or lot of land, with the buildings and improvements
thereon, lying and being on the southeasterly side of Patricia Avenue, near the
City of Greenville, South Carolina, being shown as Lot No. 13 on Plat of White
Horse Heights, as recorded in the R. H. C. Office for Greenville County, S. C.,
in Plat Book "B" at page 135, and having according to said Plat, the following
metes and bounds, to-wit:

Beginning at an iron pin on the southeasterly side of Patricia Avenue at a point
179.7 feet southwest of the southerly corner of the intersection of Patricia Avenue
and Range View Drive, said pin being at the corner of Lots 13 and 14; and running
thence S. 41-08 E. 108 feet to an iron pin, corner Lots 13 and 15; thence S. 10-18 W.
199.5 feet to an iron pin, joint rear corner of Lots 12 and 13; thence along the
joint line of said Lots N. 19-18 W. 175 feet to an iron pin on the southeasterly

And it is Further Agreed, That said Mortgagor(s) shall pay promptly all taxes assessed and chargeable against said
property, and in default thereof, that the holder of this mortgage may pay the same, whereupon the entire debt secured
by this mortgage shall immediately become due and payable, if the Mortgagor shall so elect.
It is the intent and meaning of the parties that if Mortgagor(s) shall pay or cause to be paid unto Mortgagor all debts
and sums of money accrued hereby, with interest thereon, if any shall be due, then this deed of bargain and sale shall
