All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 188 on plat of Del Norte Estates, Section 11, recorded in Plat Book 4N at pages 12-13 in the RMC Office for Greenville County, and fronting on Del Norte Road, having the following metes and bounds:
