TO ALL WHOM THESE PRESENTS MAY CONCERN: J. WESLEY DAVIS, CHURCHILL A. CARTER and RALPH S. CRAWLEY

(hereinafter referred to as Mortgagor) SEND (S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto J. B. STEPHENS (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of EIGHTEEN THOUSAND SEVEN HUNDRED FIFTY AND 00/100----- DOLLARS (\$ 18,750.00) with interest thereon from date at the rate of 6 per centum per annum, said principal and interest to be repaid as follows: Payable on Demand.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs or for any other purposes

NOW KNOW ALL MEN, That the Mortgagor in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the signing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its heirs, successors and assigns the following described piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon: An undivided three-fourths (3/4) interest in and to that certain piece, parcel or tract of land in the State and County aforesaid on the Easterly edge of Miller Road, containing 35.4 acres, more or less, as shown on survey for Carter & Crawley, Inc., dated March 30, 1972, and recorded in the Office of the R.M.C. for Greenville County in Plat Book 4-Q at Page 30 and having recorded on said plat the following metes and bounds:

BEGINNING at an iron pin on the Easterly edge of the right-of-way of Miller Road, Joint front corner of the property described herein and property, now or formerly, of Patterson Warehouse Textile Co., Inc. and running thence S. 89-27 E. 700.0 feet to an iron pin; thence N. 8-17 W. 360 feet to an iron pin; thence N. 84-45 E. 1504.5 feet to an iron pin; thence S. 61-3 W. 1148.53 feet to an iron pin; thence S. 82-23 W. 369.4 feet to an iron pin; thence N. 61-23 W. 136.5 feet to an iron pin; thence N. 57-01 W. 237.4 feet to an iron pin; thence N. 83-30 W. 252.0 feet to an iron pin; thence N. 73-35 W. 203.8 feet to an 18-inch Hickory; thence S. 71-50 W. 475.05 feet to an iron pin; thence N. 38-38 W. 225.2 feet to an iron pin; thence N. 1-04 E. 319.5 feet to an iron pin; thence N. 89-27 W. 325.6 feet to an iron pin on the Easterly edge of the right-of-way of Miller Road; thence along the Easterly edge of the right-of-way of Miller Road N. 7-10 W. 50.0 feet to an iron pin, the beginning point.
