WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of ----- Twenty-one Thousand and 00/100-----

DOLLARS (\$21,000.00-----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being in Greenville County, South Carolina, being shown as Lot 31 on plat of Avon Park recorded in Plat Book KK at page 71 in the RMC Office for Greenville County, and having the following metes and bounds:

Beginning at an iron pin on Avon Drive at the joint front corner of Lots 30 and 31; thence N 67°05' E 214.6 feet to an iron pin; thence S 24°-14' E 36.4 feet to an iron pin at joint rear corner with Lot 32; thence with line of Lot 32, S 56°-42' W 210 feet to an iron pin on Avon Drive; thence with said Drive, N 30°-30' W 60 feet and N 19°-19' W 60 feet to the beginning corner.
