WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, at the intersection of Lanceway Drive and Libby Lane, being known and designated as Lot 79, Section 2 of a subdivision known as Hillsborough as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book 4-F at Page 51 and having, according to said plat, the following metes and bounds; to-wit:

"BEGINNING at an iron pin on the eastern side of Lanceway Drive, and front corner of Lots 78 and 79 and running thence with the joint line of said less. N. 57-24 E. 140 feet to an iron pin; thence S. 32-36 E. 146.5 feet to an iron pin on the northern side of Libby Lane; thence with Libby Lane, S. 72-33 W. 120 feet to an iron pin; thence continuing with Libby Lane as it intersects with Lanceway Drive, following the curvature thereof. N. 70-02 W. 39.7 feet to an iron pin on the eastern side of Lanceway Drive; thence with Lanceway Drive, N. 32-36 W. 82.7 feet to the beginning corner; being the same conveyed to us by Joe E.
